# **MOPEC Autopsy Saw**



The MOPEC Autopsy Saw is a specialized tool designed for the removal and cutting of bone specimens. It is not for consumer use and should be:used only by qualified personnel experienced in Autopsy Room procedures.

## WARNINGS

- **1.** Read instructions completely to assure proper operation.
- 2. Dull or damaged blades should never be used.
- **3.** While in use, keep hands away from the oscillating blade.
- **4.** As with all electrical devices, proper care and consideration should be given to the operation of the autopsy saw.
  - **A.** Immersion in any liquid or autoclaving may-result in an electrical shock hazard or permanent damage,
  - **B.** Grounding continuity should be checked periodically.
  - **C.** The power supply cord should be kept away from the cutting area at all times.
  - **D.** When disconnecting the autopsy saw from an outlet, pull on the plug. Never disconnect by pulling on the cord.
  - **E.** In order to assure proper grounding, plug the unit into a receptacle marked "Hospital Grade."
  - **F.** Do not operate in areas where flammable or explosive vapors may be present.
- **5.** Consideration should be given to the airborne contamination created during the cutting process.
- 6. MOPEC REMINDER: USE OF THIS INSTRUMENT INVOLVES ROUTINE DIRECT CONTACT WITH BLOODBORNEPATHOGENS. MOPEC STRONGLY RECOMMENDS COMPLIANCE WITH OSHA'S UNIVERSAL SAFETY PRECAUTIONS WHEN HANDLING THIS INSTRUMENT.

## **ASSEMBLY**

- 1. Loosen arbor set screw with the wrench provided.
- **2.** Insert blade arbor to its fullest depth in the triangle output shaft.

## **IMPORTANT**

- **3.** Do not over-tighten arbor set screw with the wrench provided!
- **4.** Connect the Autopsy Saw power cord to the appropriate wall outlet.



Adequate grounding can be assured only when connected (to an equivalent receptacle marked "Hospital Grade." 5. The saw is ready for use.

#### **OPERATION**

For cutting bone, a series of up and down motions combined with linear movement is recommended- Hold the unit with one hand as illustrated, slide the switch to the "ON" position and, using the thumb as a gauge, depress blade into the bone,

The blade should be inserted at a slight angle into the bone until the cutting pressure lessens indicating that the blade is through the bone. The blade should then be lifted leaving the tip in the cutting groove, and then advance along the cutting line about one-half inch and repeat as above. **DO NOT exert excessive working pressure**.



**Operating Technique** 

#### MAINTENANCE, CARE AND SERVICE

Bearing Lubrication—None required. Bearings are lubricated for the life of the saw.

The unplugged unit may be cleaned with a soft damp doth or sponge dampened with disinfectant detergent Wipe dry.

The open motor construction is necessary for cool operation. Steam sterilization, immersion in liquids, or autoclaving will seriously damage internal motor components.

Appropriate selection, use and maintenance of a sharp blade is necessary for safe, efficient cutting. Additional friction caused by a dull blade will create excessive blade heat.


## LIMITED WARRANTY
